

## Photoflex®, Inc. Trademark and Copyright Terms and Conditions

These Trademark Usage Guidelines (the “Guidelines”) set forth the rules for using or referring to the trademarks and service owned by Photoflex®, Inc. or its affiliates (“Photoflex®”). For the purposes of these Guidelines, “Photoflex® Trademark(s)” shall include all registered or unregistered trademarks and service marks (such as words, names, symbols, devices, slogans, or combination of these) owned by Photoflex® including but not limited to the trademarks and service marks listed on the Photoflex® Trademark List.

Photoflex® considers its trademarks and service marks to be among its most valuable intellectual property assets. As such, Photoflex® intends to take all appropriate measures to preserve the strength of and retain its exclusive rights to use its marks. Photoflex® asks that you assist us by following these Guidelines.

### Prohibited Uses of Photoflex Trademarks

1. **Do Not Use Trademarks As The Name Of Your Company, Products, Or Services, Or As A Domain Name.** You may not use or register in any jurisdiction, whether foreign or domestic, any Photoflex® Trademark as all or part of your company, product, or service name in a manner that is likely to create confusion as to the sponsorship of Photoflex®, affiliation or endorsement of your company, product, or service, or that may dilute the Photoflex® Trademark. Similarly, you may not sue or register in any jurisdiction, whether foreign or domestic, a domain name that incorporates any Photoflex® Trademark in bad faith or in a manner that is likely to create confusion as to the sponsorship of Photoflex® affiliation or endorsement of your company, product, or service.
2. **Do Not Use Photoflex® Logos Without Permission.** You may not use any Photoflex® logo unless you have an agreement with or express written consent from Photoflex® authorizing such use.
3. **Do Not Use Photoflex® Trademarks In False Or Misleading Advertising.** Advertising for Photoflex® or its products or services offered under the Photoflex® Trademarks must not be false or misleading in any way and must not be in violation of any applicable law, municipal ordinance, or administrative agency regulation of any country.
4. **Do Not Use Photoflex® Trademarks In Questionable Material.** You may not use Photoflex® Trademarks on or in connection with defamatory, scandalous, or other objectionable materials of any sort.
5. **Do Not Use Photoflex® Trademarks To Disparage Photoflex®.** You may not use Photoflex® Trademarks to disparage Photoflex®, its products or services, or in a manner that, in the reasonable judgment of Photoflex®, may diminish or otherwise damage the reputation of Photoflex® or the goodwill in the Photoflex® Trademarks.

### Permissible Uses Of Photoflex® Trademarks

1. **Use Of Photoflex® Trademarks To Refer To The Product Or Service Of Photoflex®.** With the exception of Photoflex® logos (the use of which must be expressly authorized by Photoflex®), you generally may use Photoflex® Trademarks to refer to the product or services in advertising of Photoflex®, promotional, and sales materials, assuming that you have the necessary authority to sell or promote products or services of Photoflex®, e.g. authorized reseller, licensee, etc.

### Rules For Proper Usage Of Photoflex® Trademarks

Proper usage of Photoflex® Trademarks is important for their continued protection. Proper usage aids consumers who depend upon the goods and services of Photoflex® and help prevent Photoflex® Trademarks from losing their

distinctiveness and becoming generic. Licensees of Photoflex<sup>®</sup> Trademarks may have different rules of usage set forth in their license agreement, in which case Licensees should follow those guidelines.

1. **Use The Proper Trademark Symbol.** A Photoflex<sup>®</sup> Trademark should appear with the proper trademark symbol, which can be found on the Photoflex<sup>®</sup> Trademark List. In written materials, the appropriate symbol must be used with the most prominent appearance of the Photoflex<sup>®</sup> Trademark in headlines and the first time the Photoflex<sup>®</sup> Trademark appears in body text. This appropriate symbol also should be used on each subsequent page or if the pages can be separated and distributed independently. Always use on all heading bold text, titles, and always use the registered “®” symbol on Photoflex<sup>®</sup>.
2. **Use The Proper Trademark Attribution Statement.** All marketing collateral, advertisements, product packaging, web pages, manuals, and studies that include Photoflex<sup>®</sup> Trademarks also must include the proper trademark attribution statement crediting ownership of Photoflex<sup>®</sup> Inc. Typically, the attribution statement is displayed at the end of the material, in the footer of the document, or on the back of the package. The correct trademark attribution statement is:

Photoflex<sup>®</sup>, the Photoflex<sup>®</sup> Logo [if applicable] [and any other trademark found on the Photoflex<sup>®</sup> Trademark List that are referred to or displayed in the document] [are] trademark[s] or registered trademark[s] of Photoflex<sup>®</sup>, Inc. or its affiliates in the U.S. and other countries. Other names may be trademarks of their respective owners.

### Usage Rules for Photoflex<sup>®</sup> Logos

You may not use any Photoflex<sup>®</sup> logo unless you have an agreement with or express written consent from Photoflex<sup>®</sup> authorizing such use. In the event that you are authorized to use a Photoflex<sup>®</sup> logo, the use must comply with these additional guidelines (or the usage guidelines set forth in your license agreement, if those guidelines differ).

1. **Use Only The Approved Master Artwork.** The Photoflex<sup>®</sup> logos are single, standalone pieces of artwork. When reproducing the logos, use only the master artwork provided by Photoflex<sup>®</sup>. Do not alter or distort the appearance of the logo in any way, for example, by adding your own design elements or colors or changing the font. The logo must always look sharp, clean, and well produced.
2. **Allow A Minimum Clear Space Around The Photoflex<sup>®</sup> Logo.** Always allow for a minimum clear space around the Photoflex<sup>®</sup> logo. Never violate the clear space with any graphic elements, words or charts.
3. **Maintain Legibility.** Never reproduce the logo in a manner that causes the logo to become illegible or blurry, which may happen if the logo is reproduced too small.
4. **Do Not Use Photoflex<sup>®</sup> Logos As A Decorative Device.** Do not use any Photoflex<sup>®</sup> logos for purely decorative purposes in any marketing collateral, packaging, or web site without the express written permission of Photoflex<sup>®</sup>.
